





# UNIVERSITY OF HUELVA RECTORAL RESOLUTION XX/2025

# APPROVING THE REGULATORY BASES AND THE CALL FOR THE 5TH PHOTOGRAPHY CONTEST "ERASMUS LOOKS" OF THE UNIVERSITY OF HUELVA

Academic Year 2025–26

The University of Huelva, through the initiative of the Vice-Rectorate for Transfer and Territorial Development and the *Cátedra de la Provincia* of the Huelva Provincial Council, announces the 5th Photography Contest "Erasmus Looks" with the aim of showcasing and promoting the heritage of the province of Huelva through the eyes of Erasmus students who come to the University of Huelva for an academic mobility program.

Three prizes will be awarded to the best photographs taken by Erasmus students participating in the "Erasmus Ambassadors" program of visits to the Province of Huelva.

This call for awards is included in the Strategic Grant Plan of the University of Huelva 2025–2027 (approved by the Governing Council on January 29, 2025) under the code PES-UHU/2025/31.

Pursuant to the above, and in accordance with Article 73 of the Budget Implementation Bases of the University of Huelva for the fiscal year 2025, I hereby resolve to approve the following:

CHAPTER I. REGULATORY BASES FOR THE GRANTING OF AWARDS IN THE 5TH PHOTOGRAPHY CONTEST "ERASMUS LOOKS" OF THE CÁTEDRA DE LA PROVINCIA OF THE UNIVERSITY OF HUELVA

#### **Article 1. Purpose**

The purpose of the call for the 5th Photography Contest "Erasmus Looks", organized by the *Cátedra de la Provincia* of the University of Huelva, is to reward the photographs that best show the beauty of our province through the eyes of Erasmus students.

Three prizes will be awarded: first, second and third place, with amounts of €500, €300, and €200 respectively.

# **Article 2. Requirements**

Applicants must meet the following requirements:







- Be over 18 years of age.
- Follow the @unihuelva accounts.
- Have attended any of the visits organized by the *Cátedra de la Provincia* on **November 7**, **14 and 28**, **and December 12**, **2025**, **and February 20** and **March 6**, **2026**.
- The Instagram account must be public.
- The photos must be original and taken during the visits organized by the *Cátedra*, and must not infringe any intellectual or industrial property rights, data protection, or any other rights of third parties.

Participants who fail to meet these requirements will not be eligible and will be disqualified.

#### Article 3. Evaluation criteria

The evaluation criteria for the submitted photographs will be:

- Technical and aesthetic quality.
- How well the photograph conveys the contest theme.
- The level of interaction achieved (likes and comments) on the posts.

#### **Article 4. Amount of the prizes**

First prize: €500
Second prize: €300
Third prize: €200

#### Article 5. Obligations of award recipients

- Maintain a public Instagram account.
- The prize is personal and non-transferable and must be collected by the winner or by a designated person with written authorization.

#### **Article 6. Compatibility of awards**

Students who win a prize in this contest may not participate with the same photograph in other similar contests organized by the *Cátedras* of the University of Huelva.

# CHAPTER II. CALL FOR THE 5TH PHOTOGRAPHY CONTEST "ERASMUS LOOKS" OF THE CÁTEDRA DE LA PROVINCIA OF THE UNIVERSITY OF HUELVA

## **Article 7. Purpose and scope**

The procedure for granting the prizes shall follow the competitive process set out in Article 22 of Law 38/2003, of November 17, in accordance with the principles of publicity, transparency, objectivity, equality and non-discrimination, efficiency in achieving objectives and effectiveness in the allocation and use of public resources as stated in Article 8.3 of said law.







# **Article 8. Funding**

The amount of the prizes will be charged to the following budget items:

# **Article 9. Competent bodies**

- 1. The evaluation and selection of the photographs proposed for the prizes will be carried out by a jury composed of professionals in photography and experts in the heritage of the province of Huelva. The *Cátedra de la Provincia* reserves the right to modify the composition of the jury.
- 2. The management of this procedure will be carried out by the director of the *Cátedra*.

#### Article 10. Application procedure and deadline

2026. The submission period will open until March remain Participants may submit as many photos as they wish by posting them on their feed with the hashtag #ErasmusLooks\_HUELVA2025. The Instagram account must be public. From the images posted within the indicated period, the jury will select the best photographs.

The contest will take place via Instagram. We are looking for original photos of Huelva and of the places visited by Erasmus students during the visits organized by the *Cátedra de la Provincia* of the University of Huelva that show the beauty of our province through the Erasmus student's perspective.

#### Article 11. Decision and notification

The Vice-Rector for Transfer and Territorial Development will issue, within **15 days** after the closing of the call, a resolution by means of an official record and may declare any of the prizes void. Once the provisional award decision is published, a **five-day period** for appeals will be opened. After this period, and once any appeals have been resolved, the final award decision will be issued and made public.







## **Article 12. Publication and communication**

In accordance with Law 38/2003, of November 17, General Law on Grants, the contest will be published in the Official Gazette of the Regional Government of Andalusia (BOJA) and in the National Subsidies Database (BDNS): http://www.pap.minhap.gob.es/bdnstrans/index

Other resolutions related to the prizes will be published on the Official Electronic Bulletin Board (TEO) of the University of Huelva: https://sede.uhu.es/teo.php

For information purposes, the call and subsequent resolutions will also be published on the *Cátedra de la Provincia* website.

Winners will additionally be notified by email and asked to sign and submit a prize acceptance form. If any winner cannot be contacted within **five days**, the jury may select new winners.

The prize is personal and non-transferable and must be collected by the winner or an authorized representative.

#### **Article 13. Payment of prizes**

Payment of the prizes will be made directly by the University of Huelva via bank transfer to the winner's account, once the final award resolution has been published.

#### **Article 14. Revocation of prizes**

The Cátedra de la Provincia may disqualify any participant who fails to comply with the established rules or who is deemed to have participated fraudulently.

If a prize winner fails to fulfill the obligations set forth in these rules, hides information, or falsifies data, the *Cátedra de la Provincia* reserves the right to reclaim the prize awarded.

The Cátedra de la Provincia of the University of Huelva also reserves the right to exclude from the promotion any participant who, in its judgment, participates improperly, or who defrauds, alters, or disrupts the proper functioning and normal course of the contest, including those suspected of irregular behavior.

#### **ADDITIONAL PROVISIONS**

- The Cátedra de la Provincia will resolve any issue not foreseen or detailed in these rules, and will make such decisions public through any means deemed appropriate to ensure transparency.
- Participation implies authorization for the *Cátedra de la Provincia* to publish the names of the winners and the winning photographs.







- In the event of improper participation detected after the prize has been awarded, the *Cátedra de la Provincia* reserves the right to take legal action, including demanding the return of the prize.
- By accepting these rules, participants grant the *Cátedra de la Provincia* and the University of Huelva the right to use their name and image. Participants consent to the worldwide publication and reproduction—without limitation—of their name, image, and winning photo in any advertising, promotion, or publication (including the Internet), with promotional or informational purposes related to this contest, without any financial compensation beyond the awarded prize.
- The Cátedra de la Provincia reserves the right to modify at any time the conditions of this contest, including its possible cancellation before the scheduled deadline, for justified reasons, committing to communicate any new terms, conditions, or final cancellation.
- The University of Huelva is not responsible for any participation failures due to malfunctioning of the Internet or Instagram (as it is an independent platform), interruptions, delays, incomplete submissions, unauthorized access, or errors in receiving information, nor for any damages caused to users.
- Participation in the contest implies full acceptance of these rules and of the interpretative criteria of the University of Huelva in resolving any issue arising from this promotion.
- Instagram does not sponsor, endorse, or administer this contest in any way, nor is it associated with it. Participants understand that they are providing their information to the University of Huelva, which will use it solely to manage participation and, if applicable, to communicate the award, and Instagram is fully exempt from any responsibility toward participants.

Against this resolution, which terminates the administrative process, an optional appeal for reconsideration may be lodged with the Rector of the University of Huelva within one month from the day following its publication, or an administrative-contentious appeal within two months before the Administrative Courts, in accordance with Articles 8 and 46.1 of Law 29/1998, of July 13, and Articles 123 and 124 of Law 39/2015, of October 1, on Common Administrative Procedure of Public Administrations.

The University of Huelva undertakes to handle personal data respectfully and in accordance with current data protection regulations.

By participating in this contest, users accept these rules. These general conditions shall be interpreted in accordance with Spanish law.
